## What data do we collect?

OLXR Limited collects the following data:

- Personal identification information (Name, email address, phone number, etc.)

## How do we collect your data?

You directly provide OLRX Limited with most of the data we collect. We collect data and process data when you:

- Register online or place an order for any of our products or services.
- Voluntarily complete a customer survey or provide feedback on any of our message boards or via email.
- Use or view our website via your browser's cookies.

## How will we use your data?

OLXR Limited collects your data so that we can:

- Process your order and manage your account.
- Email you with special offers on other products and services we think you might like.

If you agree, OLXR Limited will share your data with our group companies so that they may offer you their products and services.

When OLXR Limited processes your order, it may send your data to, and also use the resulting information from, credit reference agencies to prevent fraudulent purchases.

### How do we store your data?

OLXR Limited securely stores your data inside of the European Union.

OLXR Limited will keep your data while we feel it is relevant or you instruct the deletion of such data.

### Marketing

OLXR Limited would like to send you information about products and services of ours that we think you might like, as well as those of our partner companies.

If you have agreed to receive marketing, you may always opt out at a later date.

You have the right at any time to stop OLXR Limited from contacting you for marketing purposes or giving your data to other members of the OLXR Limited Group.

If you no longer wish to be contacted for marketing purposes, please contact us and we will remove you from the relevant marketing list(s).

### What are your data protection rights?

OLXR Limited would like to make sure you are fully aware of all of your data protection rights. Every user is entitled to the following:

**The right to access** – You have the right to request OLXR Limited for copies of your personal data. We may charge you a small fee for this service.

**The right to rectification** – You have the right to request that OLXR Limited correct any information you believe is inaccurate. You also have the right to request OLXR Limited to complete the information you believe is incomplete.

**The right to erasure** – You have the right to request that OLXR Limited erase your personal data, under certain conditions.

**The right to restrict processing** – You have the right to request that OLXR Limited restrict the processing of your personal data, under certain conditions.

**The right to object to processing** – You have the right to object to Our Company's processing of your personal data, under certain conditions.

**The right to data portability** – You have the right to request that OLXR Limited transfer the data that we have collected to another organization, or directly to you, under certain conditions.

If you make a request, we have one month to respond to you. If you would like to exercise any of these rights, please contact us using the latest contact details outlined on our website.

## Cookies

Cookies are text files placed on your computer to collect standard Internet log information and visitor behavior information. When you visit our websites, we may collect information from you automatically through cookies or similar technology

## What types of cookies do we use?

There are a number of different types of cookies, however, our website uses:

- **Functionality** – OLXR Limited uses these cookies so that we recognize you on our website and remember your previously selected preferences. These could include what language you prefer and location you are in. A mix of first-party and third-party cookies are used.
- **Advertising** – OLXR Limited uses these cookies to collect information about your visit to our website, the content you viewed, the links you followed and information about your browser, device, and your IP address. OLXR Limited sometimes shares some limited aspects of this data with third parties for advertising purposes. We may also share online data collected through cookies with our advertising partners. This means that when you visit another website, you may be shown advertising based on your browsing patterns on our website.

## **How to manage cookies**

You can set your browser not to accept cookies, and the above website tells you how to remove cookies from your browser. However, in a few cases, some of our website features may not function as a result.
